LEGAL AND COMMUNITY SAFEGUARDING

MEMBERS INFORMATION NOTE

Safeguarding Training

Safeguarding relates to the action taken to promote the welfare of children and adults at risk and protect them from harm.

Safeguarding is everyone's responsibility and all NHC employees, volunteers and members have a duty to take action to safeguard children and adults at risk in our communities.

NHC offers two levels of training and the level of training required is determined by how much contact, be that direct or indirect (email, telephone, post etc.) you have with children and adults including access to personal and sensitive information about them.

The levels of training are:

Basic

- a 3-hour long course which is required to refresh every 3 years.
- This is for any member that has contact, either directly or indirect with children and adults and/or access to personal and sensitive information.
- There are separate basic courses for children and adults at risk.

Advanced

- a 6-hour course which is required to be refreshed every 3 years.
- This is for any member who manages another member or is a Designated Safeguarding Officer.
- There are separate advanced courses for children and adults at risk.



Town Centres and Retail Strategy (SERVICE AREA, REGULATORY)

MEMBERS INFORMATION NOTE

Invitation to Retail and Town Centres Stakeholder Workshop Thursday June 13th @ 9:00 – noon DCO Council Chamber

In January 2024, a Member Information Note was provided to give notice that the Council had commissioned Lichfields to produce a Town Centres and Retail Study – in line with "the Council's Delivery Plan 2023/24 which sets out the requirement to develop 'town centre strategies', based on a high-level report covering the whole district." The study to date has included a: Household Telephone Survey, which was conducted between January and February 2024, and a Stakeholder Online Survey, which was conducted between February and March 2024. Alongside these surveys, Lichfields have been analysing market research and conducting town centre health checks to produce evidence for the study.

Members are invited to attend a stakeholder workshop that the officers, together with Lichfields, will be hosting. The initial findings of the Town Centres and Retail study will be presented. This will take place on <u>Thursday 13 June at 9:00</u> am – 12:00 pm in the District Offices, Council Chambers.

The invited stakeholders include town centre property owners, property management agencies, charities, colleges, societies, Business Improvement Districts, and trusts, as well as Members. This workshop has been commissioned to present the information gathered to date and to gather further input from the stakeholders. The workshop will inform the final production of the North Herts Town Centre Strategy. While this is a workshop for stakeholders, and thus a daytime event, Members are also very welcome to attend.

The Town Centres and Retail Study will become a component of the evidence base to inform the council's policy on town centres, both for the emerging Town Centres Strategy and the review of the Local Plan.

It is anticipated that the new Town Centres Strategy, will be presented to Cabinet in Autumn 2024, for formal consultation, prior to its adoption as Council policy in early 2025.

Trampolines join climbing nets, swing sets, and a roller-running disk at the renovated junior play area at Bancroft Recreation Ground in Hitchin.

The council, with the help of landscape architects at Groundwork East, has remodelled the area to improve the play experience for children aged around 5 to 12, by making it safer, brighter and more inviting.

Sarah Kingsley, North Herts Council's Service Director for Place said: "We're so happy to have the area open again, it really is a fabulous makeover! In response to feedback from consultations, the area has been redesigned to incorporate more swings and climbing opportunities, softer landscaping, picnic tables, and we've retained and refurbished the pirate ship."

Catherine Browne, Landscape Architect at Groundwork East, the environmental charity, said: "There is a great deal of new play equipment in a more considered layout with accompanying sensory planting, which really transforms the area into a lovely space for lots of people to enjoy.

"We have particularly tried to expand the play provision to include play for children (and adults!) with diverse needs, and ensured we made space for women and girls within the design by expanding provision for imaginative play and storytelling. Not to mention removing as much hard surfacing as possible to create a more climate resilient and cooler play area. Everyone has worked immensely hard on this project, we hope you love it as much as we do!"

Sarah added: "We know this is a popular spot so thanks for people's patience with the slight delay with reopening, although it was really disappointing to hear of the abuse and intimidation one of our contractors suffered by people complaining that it was closed. We do not tolerate abuse against staff or contractors. In addition, we've heard of children and adults being in the closed area which is not safe, and could have resulted in injury and damaged equipment that council taxpayers would end up paying for."

He held several terms as Chair and Vice Chair of Baldock and District Area Committee, including most recently from May 2020 to May 2021. In the 2023/24, he was appointed as a North Herts Council representative at the Baldock Town Twinning Association, the Baldock United Almshouse Charities, the Baldock Community Forum, and the Baldock Youth and Community Association.

For those wishing to pay their respects, the funeral will be held on Wednesday 12 June at 1.45pm at St Mary's Church in Baldock.

New Leader and Cabinet for North Herts Council

Following our 'all out' elections in May, when all of our councillors were elected at the same time, changes to the council's Cabinet were announced last night (23 May) at Annual Council.

With 25 Labour & Co-operative councillors, 19 Liberal Democrats and 7 Conservative, there is still no overall control of the council. The council will now be run as a Labour & Co-operative 'minority administration', this is when a party governs a council despite not having more than half of all councillors – in North Herts a party would need 26 councillors. This follows two years of a joint Labour & Co-operative and Liberal Democrat administration.

Following a recent district ward boundary review, we now have 51 councillors (previously 49), of whom 19 are new this year, and our councillors are now spread across 25 wards (previously 24).

Cllr Daniel Allen (Labour & Co-operative) is now Leader of North Herts Council, the Liberal Democrat Group Leader continues as Cllr Ruth Brown, and the Conservative Group Leader is now Cllr Ralph Muncer.

The post of Leader is usually elected by all members of the council after a local election which now takes place every four years in North Herts. The Leader chairs all meetings of the council's Cabinet and leads on policy development.

The cabinet positions are now:

- Cllr Daniel Allen Leader of the Council
- Cllr Chris Hinchliff Executive Member for Planning & Transport
- Cllr Ian Albert Executive Member for Finance & IT

- Cllr Val Bryant Executive Member for Communities & Partnerships (and Deputy Leader)
- Cllr Tamsin Thomas Executive Member for Enterprise & Arts
- Cllr Amy Allen Executive Member for Recycling & Waste Management
- Cllr Mick Debenham Executive Member for Environment, Leisure & Green Spaces
- Cllr Dave Winstanley Executive Member for Housing & Environmental Health

In addition to the cabinet roles, the new Chair of the Council is Cllr Clare Billing and Vice-Chair is Cllr Tina Bhartwas. The Chair is also elected by all members of the council and is the civic leader of North Herts, who represents the council at a wide range of public events on a non-party political basis and supports charities of their choice throughout their term in office.

Cllr Daniel Allen, Leader of North Herts Council, said: "Being elected Leader of the Council is an honour and a responsibility that I take very seriously. As I step into this role, I promise to lead with openness, transparency, and a genuine commitment to the values and needs of our community. I would like to thank Cllr Elizabeth Dennis for her excellent work as Leader of the Council which has put us in this strong position going forward."
