## North Herts Council response to the National Planning Policy Framework (NPPF) Consultation

The Government recently consulted on proposed changes to the National Planning Policy Framework (NPPF).

The NPPF is a material consideration when deciding planning applications. It also guides how we produce policy documents such as the Local Plan, Neighbourhood Plans and Supplementary Planning Documents. The policies and requirements of the NPPF are identified, as applicable, in officer reports and recommendations to Planning Control Committee, Cabinet and Full Council.

The NPPF consultation raised a number of issues that were comprehensively debated at the Full Council meeting of Thursday 19 September 2024 in response to the guestions and motions that were tabled.

The outcomes of these informed the consultation response. The letter setting out the key elements of this Council's response is attached.

A copy of the full response, including the technical appendix referenced in the attached letter, has been provided to the Planning Executive and Shadow Executive Members for each Group.

## Proposed reforms to the National Planning Policy Framework and other changes to the planning system

Thank you for consulting us on your proposed reforms to the NPPF and other changes to the planning system. We have considered your proposals.

This raises a number of issues that were comprehensively debated at our Full Council meeting of Thursday 19 September 2024 in response to questions and motions submitted for consideration by local Councillors.

As part of the consultation, the Government announced not only would it be re-introducing mandatory housing targets for Local Authorities, but that it would increase overall targets from 300,000 new homes per annum to approximately 370,000 per annum.

Under the Government's proposed new method announced as part of changes to the National Planning Policy Framework, North Hertfordshire will be required to build 992 new homes per year, representing an increase of 9%.

Neighbouring authority Luton will see its housing target reduced by 22%, and as a result of the Government removing the urban uplift, major cities such as London, Liverpool and Birmingham will all see a reduction in their housing targets by up to 31%.

Following the adoption of the North Hertfordshire Local Plan in November 2022, 47% of land within the district is designated as Green Belt. The reforms of which are proposed by the Government will weaken protections for Green Belt land, and could result in inappropriate development taking place within the district, particularly in and around our rural communities.

As a result of our Local Plan having recently been adopted, North Hertfordshire currently does not need to provide evidence of a five-year housing land supply in accordance with the 2023 NPPF. However, the Government is proposing to remove this element of the 2023 NPPF, which means that should this proposed change come into force there would be a presumption in favour of sustainable development through the decision-making mechanism. The loss of this protection

increases the likelihood of approval for major developments proposed within the district on sites not identified in the Local Plan.

Despite the existence of unimplemented planning permission to build more than a million homes across England, the current government, like its predecessor, believes that making it easier for developers to get planning permission is the way to increase the availability of affordable housing. The council believes that increasing numbers of permissions, rather than focusing on building the right housing in the locations which are already identified for development will boost developers profits, rather than meeting the needs for affordable housing. It also notes that the government's proposed changes to the NPPF would make it easier for developers in North Herts to obtain planning permission on speculative sites, including those in parts of the Green Belt

The Government has also stated its ambition to build "a new generation of new towns" which will comprise of at least 10,000 homes. In order to identify potential locations for these 'new towns' a New Towns Taskforce has been created within the Ministry of Housing Communities and Local Government

In response to these matters, Council resolved that we should call on the Government to:

- 1. Not increase the Housing Target for North Hertfordshire.
- 2. Restore the Urban Uplift, ensuring cities and urban areas take their fair share of housing development, particularly as many of these areas already have the infrastructure to support additional development.
- 3. Ensure infrastructure to support approved development is built prior to houses, thereby reducing the negative impact of development on existing communities, and ensuring local infrastructure is ready to provide for residents moving into new homes.
- 4. Adopt a brownfield first approach to development, and provide greater protection for green belt land in North Hertfordshire.
- 5. Not to amend paragraph 11(d) of the 2023 NPPF, which currently provides protection for North Hertfordshire as a local authority that has recently adopted a local plan but does not have a five-year housing land supply.
- 6. Strengthen the rights of local residents to ensure they have a meaningful say when development is proposed within their communities.
- 7. Not remove the emphasis and focus on 'beauty' and 'beautiful design' from the National Planning Policy Framework.
- 8. Meaningfully engage with Local Planning Authorities on the New Town Scheme and where proposed sites are put forward within an area ensure that plans have local consent and that sufficient additional funding is in place to support already-stretched planning departments.
- 9. Actively pursue reforms designed to ensure that a far greater proportion of planning applications which continue to be approved under the existing policy framework are actually built out by developers in a timely manner, recognising that this is the most effective way of meeting the Government's stated objectives.
- 10. Adopt a strategy that will prioritise increasing delivery of affordable housing with appropriate infrastructure and to prioritise giving more power to councils to build housing, in particular social and affordable housing.

We recognise that Point (8) above is not being directly consulted upon as part of the NPPF consultation. However it is of relevance to your consideration of future strategic planning arrangements.

Officers of the Council have additionally prepared technical responses to many of the detailed questions contained in the consultation. These are set out in the attached Appendix alongside

the resolutions of the Council set out above. Officer comments reflect their objective, professional opinions and expertise on these matters. These should be taken into consideration recognising that, where comments relate to matters other than those set out above, these are not presently formally endorsed positions of the Council.



#### 1 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor Val Bryant.

#### 2 MINUTES - 12 JUNE 2024

**RESOLVED:** That the Minutes of the Meeting of the Committee held on 12 June 2024 be approved as a true record of the proceedings and be signed by the Chair.

#### 3 CHAIR'S ANNOUNCEMENTS

- (1) The Chair advised that, in accordance with Council Policy, the meeting would be recorded.
- (2) The Chair drew attention to the item on the agenda front pages regarding Declarations of Interest and reminded Members that, in line with the Code of Conduct, any Declarations of Interest needed to be declared immediately prior to the item in question.

#### 4 SCF MINUTES

**RESOLVED:** That the Committee noted the minutes of the Staff Consultation Forum for June, July, August and September 2024.

#### 5 HR INFORMATION NOTE

The Human Resources Services Manager presented the Information Note entitled 'HR Update'.

#### 6 DISCUSSION PAPER - COACHING

**RESOLVED:** That the Committee commented on and noted the Discussion Paper on Coaching.

#### 7 SUGGESTED DISCUSSION TOPICS

The Chair suggested two topics 'Mental Health' and 'Neurodiversity in the Workplace' for the next meeting of the Committee and this was agreed with Members present.

#### RECORD OF DECISION MADE UNDER DELEGATED AUTHORITY

#### **PART 1 – PUBLIC DOCUMENT**

Any interest to declare/ or conflict and any dispensation granted for the Officer or Executive Member [YES, the Executive Member for Community and Partnerships declared an interest in relation to grant 1.1.1 so the decision has been passed to the Leader of the Council in consultation with the Service Director – Legal and Community. See Legal implications]

Any conflict with any Member of the Panel and the bodies concerned

[ YES – Cllr Tina Bhartwas. However, she declared his interest and therefore did not take part in the voting on this application.]

#### **SERVICE DIRECTORATE:** Legal and Community

#### 1. DECISION TAKEN

- 1.1 The approval of the allocation **North Herts Prosperity Fund** funding of:
- 1.1.1 **£14,622** to NORTH HERTS & STEVENAGE CVS towards their digital poverty project.

On condition that three relevant quotes are received.

#### 2. DECISION TAKER

2.1 Cllr Daniel Allen, Leader of the Council, in consultation with the Service Director – Legal and Community.

#### 3. DATE DECISION TAKEN:

#### 9 October 2024

#### 4. REASON FOR DECISION

- 4.1 The **District Wide Community Facilities Capital & Revenue Grants Panel** meetings held on 3 October 2024 considered applications for the North Herts Prosperity Fund and recorded their recommendation to the Executive Member for Community and Partnerships for the formal commitment of North Herts Prosperity Fund monies via the delegated authority process.
- 4.2 As the Executive Member for Community and Partnerships is the Council's representative on the North Herts & Stevenage CVS, she has a registerable disclosable interest and therefore cannot sign off on this decision which has been delegated to the Leader of the Council.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 There are no other reasonable alternative options.

## 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 Consultation has taken place with the District Wide Community Facilities Capital & Revenue Grants Panel members in a closed meeting on 3 October 2024. Members are in favour and recommend that the North Herts Prosperity Fund should be used for this purpose.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 This grant application was considered by the District Wide Community Facilities Capital & Revenue Grants Panel on 3 October 2024.
- 8.2 This delegated decision confirms that the recommendation made by the District Wide Community Facilities Capital & Revenue Grants Panel members was accepted by the Leader of the Council, and Service Director on application 1.1.1.
- 8.2.1 Funds are only to be released on condition of receipt of relevant quotes.

#### 9. LEGAL IMPLICATIONS

- 9.1 Under the Constitution, the Executive Member for Community & Partnerships and Service Director Legal & Community have delegated authority to make these Executive decisions under section 14.6.9(b)((ii)A 5. The Executive Member has a conflict of interest in relation to the is body, therefore the Leader can exercise such powers, as per section 14.6.16.1. This decision will be subject to a five clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 9.2 This grant has been assessed against the Subsidy Control Act 2022.

#### 10. FINANCIAL IMPLICATIONS

- 10.1. The North Herts Prosperity Fund budget is £210,000.
- 10.2. Of the £210,000 allocated there is a prescribed Capital/Revenue split on the funding. The proportion of spend will be £130,000 capital funding and £80,000 revenue funding.
- 10.3. When all grants that have been recommended and those that are tabled for recommendation are taken into consideration, they represent a split of £140,657.00 capital spend and £69,343.00 revenue spend. While this does not quite meet the prescribed split set out in paragraph 10.2, this has been reviewed in the context of spend against the overall UKSPF grant and this variance does not create a problem. This has been confirmed by the Economic Development Officer and S151 Officer.
- 10.4. Of the £210,000 budget, £121,157 has been awarded, leaving £88,843 to be allocated.
- 10.5. If the grant application in this delegated decision is awarded as outlined in 1.1.1, the remaining balance will be £74,221.
- 10.3 At the meeting to be held on 18 October, there are five grant applications to be heard that total £74,221.
- 10.4 If applications at all meetings are recommended, the amount recommended / awarded will total £210,000.

#### 11. RISK IMPLICATIONS

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 11.2 There is a requirement for allocated funds to be spent by the end of March 2025. Therefore, there is a risk that we will have to request the return of funds from applicants where projects have not been completed on time. This is assessed as unlikely, as the application process included an assessment of each applicant's ability to commence their project as soon as funding is available and to progress work in a timely manner.

#### 12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 North Herts Prosperity Fund monies are awarded to groups that clearly demonstrate positive impact on the community and wider environment. The projects outlined in this report seek to advance equality of opportunity and foster good relations.

#### 13. SOCIAL VALUE IMPLICATIONS

13.1 The Social Value Act and "go local" policy do not apply to the matters contained within this report, as there are no recommendations on procurement.

#### 14. ENVIRONMENTAL IMPLICATIONS

14.1 The Fund's criteria enabled application for projects related to environment and climate. In addition to this, in further developing the criteria and scoring process applicants were asked to confirm which of the Council's priorities their project supported. Therefore, applications which fulfilled the Council's Sustainability priority were able to score an additional point for this, which could aid in boosting their overall score.

1.1 To appoint Wilmott Dixon to prepare Heat Decarbonisation plans and support for an application to the Public Sector Decarbonisation Fund.

#### 4. REASON FOR DECISION

4.1 To ensure the council had specialist support in order to successfully submit a bid for the Public Sector Decarbonisation Scheme and to deliver a Heat Decarbonisation Strategy covering the Council's remaining fossil fuel heated estate to meet requirements of grant funding awarded under the Government's Low Carbon Skills Fund (LCSF).

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 To carry out a competition via the Council's E-sourcing system for the services required, however this would not have been possible, due to the timescales required to meet the LCSF grant conditions. Wilmott Dixon also provide additional value by engaging with their construction arm to ensure the proposed schemes were deliverable and costed accurately.

## 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 The Executive Member for Environment, Leisure and Green Spaces was consulted.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### 8. BACKGROUND / RELEVANT CONSIDERATIONS

8.1 The Council was successful in its bid for funding to decarbonise our three leisure centres through the Public Sector Decarbonisation Scheme (PSDS) in Autumn 2023 and was awarded a grant of £7.74m. This project is being delivered over 2024-25 and 2025-26. Our focus is now on decarbonisation of our wider estate, particularly

- the District Council Office, North Herts Museum and Hitchin Town Hall (our priority buildings) to meet our 2030 target of being Carbon Neutral for our own operations.
- 8.2 To support this objective, the Council submitted a bid for a grant from the Low Carbon Skills Fund in April 2024 to produce heat decarbonisation plans and an overarching strategy covering our remaining fossil fuel heated estate. We were awarded this grant in July 2024. Through this grant, detailed feasibility assessments for the opportunities of low carbon heating (such as air source heat pumps) will be conducted for our priority buildings: District Council Office, Hitchin Town Hall and North Herts Museum, and the North Herts Leisure Centre learner pool. High level energy audits will also be carried out for: Royston Town Hall Annex, Grange Sports Pavilion, and Letchworth and Hitchin Lidos.
- 8.3 Having requested quotes from a number of consultancies to deliver this work, Wilmott Dixon were appointed through the SCAPE Framework to deliver the grant awarded through the LCSF, as well as to support an application to PSDS for our priority buildings: District Council Office, North Herts Museum, Hitchin Town Hall and the learner pool at North Herts Leisure Centre.
- 8.4 The priority buildings have been identified for submitting bids for PSDS funding due to our long-term commitment to these sites and their contribution to the Council's Scope 1 emissions (due to use of gas as a heating source). PSDS offers public sector organisations the opportunity to apply for funding which will help decarbonise their buildings. Therefore, applying to the fund allows the council an opportunity to decarbonise part of its estate, with a much-reduced capital outlay. Detailed applications have to be prepared for the scheme, including heat decarbonisation plans and further technical, risk and governance assessments.
- 8.4 Wilmott Dixon's appointment through the major works element of the SCAPE Framework for the initial plans would also allow us to directly award the construction contract for delivering the project to them should we be successful.

#### 9. LEGAL IMPLICATIONS

- 9.1 Under 14.6.4 (a) (ii) of the Council Constitution, Service Directors have a general authorisation for "entering into contracts to carry out works and/or for the supply of goods and services within approved budgets".
- 9.2 The Council is a member of the SCAPE Framework which allows call off by relevant partner organisations. Therefore, under the Contract Procurement Rules (11), the Council is not required to undertake a full tendering procedure and can call off from an approved external Framework Agreement (CPR 11.1, 11.3) and shall follow the call-off procedure.
- 9.3 The Openness of Local Government Bodies Regulations 2014 (No. 2095) require officers undertaking non-executive decisions to record (amongst other things) an award of a contract that materially affects the Council's position in a written delegated decision. At North Hertfordshire District Council, this is any award of a contract or financial decision, that is or is likely to be above £50,000.

#### 10. FINANCIAL IMPLICATIONS

10.1. The LCSF grant awarded to deliver this work is £39,065.00 Additionally, £35,919.80 of an existing council budget allocated for producing heat decarbonisation plans will be utilised to deliver the work and submit a funding application to PSDS. This is considered a key opportunity towards reducing our fossil fuel usage and making progress towards meeting the Council's climate commitments.

10.2. There is currently no additional capital funding allocated to deliver decarbonisation works at our priority buildings. The council plans to submit an application to PSDS which commits 2025-26 to act as a planning year with works (and associated costs) delivered in 2026-27. If the Council is successful in its bid to PSDS round 4, a capital budget proposal will be submitted.

#### 11. RISK IMPLICATIONS

- 11.1 There is a risk that the PSDS bid will be unsuccessful, or the planned works are not deliverable. However, with the LCSF funding, the financial implications of that are quite low. The work towards submitting the PSDS bid is valuable in understanding the options available and the financial implications of those options for planning future capital proposals.
- 11.2 There is also a risk that, if we are successful in our bid to PSDS round 4, that additional costs will emerge as the project develops, requiring additional capital funds to deliver. To mitigate this risk, Wilmott Dixon have engaged their construction focused colleagues earlier to get greater input in the plan designs. This is intended to ensure we gain a fuller understanding of construction costs prior to submitting a capital budget proposal.

#### 12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 There are no equalities implications arising from this report.

#### 13. SOCIAL VALUE IMPLICATIONS

13.2 The "go local" policy has not been applied because the support required is specialist in nature though the consultants appointed are locally based. Utilisation of a government grant (LCSF) to support this application has also limited opportunities to embed social value.

#### 14. ENVIRONMENTAL IMPLICATIONS

14.1 There are no Environmental implications associated with the appointment of Wilmott Dixon, though the heat decarbonisation plans that they produce will help the council understand how it can decarbonise our wider estate, thereby reducing impact on the environment. Appointing Wilmott Dixon will also result in an application to the Public Sector Decarbonisation Scheme. If we are successful, the scheme will allow us to deliver works highlighted in the heat decarbonisation plans on the Council's priority buildings. These works would achieve energy and carbon savings. As such, a full Environmental Impact Assessment will be undertaken if the council is successful with its funding application, and at the point at which formal decision is made to move forward with the decarbonisation projects.

#### 15. HUMAN RESOURCE IMPLICATIONS

15.1 Wilmott Dixon were appointed in recognition that the council does not employ specialist staff who could produce heat decarbonisation plans and also had limited capacity to pull together the application. If successful in receiving the PSDS funding, the resource implications will be considered as part of the project management process.

#### 4. REASON FOR DECISION

4.1 The **District Wide Community Facilities Capital & Revenue Grants Panel** meetings held on 3 and 4 October 2024 considered applications for the North Herts Prosperity Fund and recorded their recommendation to the Executive Member for Community and Partnerships for the formal commitment of North Herts Prosperity Fund monies via the delegated authority process.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 There are no other reasonable alternative options.

## 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 Consultation has taken place with the District Wide Community Facilities Capital & Revenue Grants Panel members in a closed meeting on 3 October and 4 October 2024. Members are in favour and recommend that the North Herts Prosperity Fund should be used for this purpose.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

- The grant applications were considered by the District Wide Community Facilities Capital & Revenue Grants Panel on 3 and 4 October 2024.
- 8.2 This delegated decision confirms that the recommendations made by the District Wide Community Facilities Capital & Revenue Grants Panel members were accepted by the Executive Member for Community and Partnerships, and Service Director on applications 1.1.1-1.1.14.
- 8.2.1 With regards to the application in 1.1.3, funds to be released on condition of receipt of robust and adopted safeguarding policies.
- 8.2.2 With regards to the applications in 1.1.6, 1.1.8, 1.1.9 and 1.1.12-1.1.14, funds to be released on condition of receipt of relevant quotes.

#### 9. LEGAL IMPLICATIONS

- 9.1 The Executive Member has delegated authority to make these Executive decisions under section 14.6.9(b)((ii)A 5 of the constitution, in consultation with the Service Director: Legal & Community. That decision will be subject to a five clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 9.2 These grants have been assessed against the Subsidy Control Act 2022. Most of the proposals in this report are not subsidies as they do not relate to the supporting of goods or services that are also available commercially. For the Creative Chefs project, whilst there is a market for groups for parents/ carers and young children, the educational aspect means that it is not considered to be a subsidy. Support for the Green Aiders project is a subsidy as an alternative would be to use a commercial gardening service. Groundworks East (along with all the grant applicants) have confirmed that if their project is a subsidy, then MFA can be applied. This is because their total subsidy funding will fall below the required threshold.

#### 10. FINANCIAL IMPLICATIONS

- 10.1. The available North Herts Prosperity Fund budget is £210,000.
- 10.2. Of the £210,000 allocated there is a prescribed Capital/Revenue split on the funding. The proportion of spend will be £130,000 capital funding and £80,000 revenue funding.
- 10.3 When all grants that have been recommended and those that are tabled for recommendation are taken into consideration, they represent a split of £140,657.00 capital spend and £69,343.00 revenue spend. While this does not quite meet the prescribed split set out in paragraph 10.2, this has been reviewed in the context of spend against the overall UKSPF grant and this variance does not create a problem. This has been confirmed by the Economic Development Officer and S151 Officer.
- 10.4 The 14 grant applications in this delegated decision total £121,157. If the grants are awarded as outlined in 1.1.1-1.114, the remaining balance will be £88,843.
- 10.5 At the meeting held on 3 October 2024, a grant application for North Herts & Stevenage CVS was heard for £14,622. This recommendation is recorded in a separate delegated decision to be approved by the Leader of the Council due to the Executive Member for Community Partnerships having a registerable disclosed interest in NH&SCVS.
- 10.6 At the meeting to be held on 18 October, there are five grant applications to be heard that total £74,221.
- 10.7 If applications at all meetings are recommended, the amount recommended will total £210,000.

#### 11. RISK IMPLICATIONS

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 11.2 There is a requirement for allocated funds to be spent by the end of March 2025. Therefore, there is a risk that we will have to request the return of funds from applicants where projects have not been completed on time. This is assessed as unlikely, as the application process included an assessment of each applicant's

ability to commence their project as soon as funding is available and to progress work in a timely manner.

#### **Good vibes at North Herts Museum!**

Get some 'Good vibes' at North Herts Museum this Black History Month with an exhibition remembering Hitchin's house parties and sound systems from the 1960s to 1990s, and how this fun and fascinating local cultural scene began and evolved.

The exhibition, on show until **27 October**, shares the stories of those who were there, of how migrants from the Caribbean arrived in Hitchin with customs and traditions to build community togetherness through socialising at house parties. Rejected from pubs and social venues by the racism of many owners and customers, the new Black community decided to continue their traditions in the front rooms and sometimes basements of their homes, creating an opportunity for people to enjoy food, drink and music together.

Matt Platt, Assistant Curator at North Herts Museum, said: "The exhibition combines, stories, pictures and objects assembled by the community, highlights some key figures from the house party and later sound system scene. Remembering popular parties hosted by people like Miss Lou at her home on Dacre Road and Mr and Mrs Johnson's parties in Periwinkle Lane."

The exhibition also shares the ingenuity of how some members of this community created their own sound systems, featuring towering speakers and amps. Hear from people like Clint Bucknor of Amegus Downbeat about how sound systems really put Hitchin on the map, with different 'sounds' and their followers coming from places as far away as Birmingham to do musical battle in town.

North Herts Museum is located on Brand Street, Hitchin, open Tuesday-Saturday 10.30am-4.30pm and Sunday 11am-3pm, and this exhibition in The Arches and general admission to the museum is free.

These events include singing, Pilates tasters, research presentations, and much more, providing crucial support for those living with Parkinson's in the area. As the group grows, these funds will make it easier for attendees to access the sessions and help the group thrive in the future.
