## Litter bin project further update:

For your reference, please see below the letter we will be sending parishes, where more than 30% of their litter bins are being considered for removal.

#### Dear Parish

As part of changes to the Councils street cleansing contract in 2025, the Council's waste team were tasked with carrying out a review of all the districts litter bins which fall under this new contract, (not including litter bins within parks or open spaces – this is a separate piece of work). This has been carried out to ensure the services are carried out efficiently and effectively on a needs basis. In November 2023, the Councils Executive (Cabinet) approved a reduction in litter bins across East and North Hertfordshire to reduce council spend by improving the efficiency of the emptying services. Litter bins have been reviewed on a case by case basis depending on the qty of bins and requirements of the individual area, so the remaining number of bins in each parish or ward will vary.

We view litter bins as an important and essential part of our service to provide a clean, safe, and pleasant environment for all to enjoy. Without them it has the potential to contribute negatively to the aesthetic of the area, which directly affects the perception of residents, neighbours, the wider community, and visitors to our district. However, in some circumstances litter bins provide little or no advantage to an area and in others may even attract more litter and dumping than if they had not been present. Each litter bin across the area is on a schedule to be emptied, and we can request our contractor carry's out an ad-hoc clearance if a bin is reported to be overflowing. This predetermined schedule is produced using parameters such as on

footfall, location, volume of usage and in some scenarios seasonality depending on the location of the bin.

As such, the main aim of the review was to ensure that our litter bins are positioned in the most appropriate location to capture litter, where there is high footfall or place of congregation (such as busy bus stops), and whilst acknowledging that other more out of town and rural areas may still require a litter bin in some locations, it has been determined that the quantity currently located in some areas is over and above the need. This has led to an uneconomical & inefficient service.

The waste team have audited all of our litter bins, measured their suitability against a set criteria; based broadly on location, requirements of the area, and qty of bins already located in the vicinity, and identified those that can be removed without any likely negative impact on the surrounding area.

In some circumstances we will look to reduce the number of smaller bins and replace with a larger bin with the same, or in some cases more capacity, we are also looking to relocate some litter bins to a more suitable location to enable it to be more useful and capture more litter in the area.

A workshop was held with Councillors from both East & North Herts Council, explaining the rationale and guidance used to support the project, and further information is available on this if required.

We are looking to commence the final stage of the project in the coming months, removing those that have been identified, or revising the type & size of bins to suit the area better. We would like to give this opportunity to the parishes and town councils that are likely to see a reduction of litter bins of 30% or greater, to contact us by 4<sup>th</sup> November if they have any particular concerns over a specific bin/s, which we will be happy to discuss further. However, it has been agreed that there will be a significant reduction in litter bins, and the team have been tasked for this to be completed by early next year.

Over the coming months you will therefore start to notice the removal, exchange or resighting of bins. Where bins are being relocated, residents within 10m of the new location, will be informed. We will of course continue to monitor the use of bins to ensure the frequency of emptying is being managed.

To re-confirm this project does not cover park or greenspace litter bins, or dog waste bins.

Notification of completion and findings of Cumulative Equality and Environment Impact Assessments for the civic year 2023/24

## **Cumulative Equality Impact Assessment**

The Council has a key role to play in advancing equality, fostering good relations between different groups within our community, and helping those who are disadvantaged to feel heard and represented. In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.

Equality analysis provides a way for the council to consider the effect of decisions on different groups protected from discrimination by the Equality Act 2010.

We must demonstrate that any analysis:

- contains sufficient information to enable a public authority to show it has given due regard to the equality duty in its decision making
- identifies methods for mitigating or avoiding adverse impact (either disproportionate disadvantage or unlawful discrimination)
- considers if there are any unintended consequences for some groups
- considers if the policy / decision will be fully effective for all target groups.

We are committed to complete equality analysis for policy decisions made by the authority.

Council reports include any equality implications and are assessed by the Policy & Strategy team. Where appropriate an impact assessment will be undertaken, and mitigation measures identified by the report author and Policy & Strategy team. The Policy & Strategy team undertake an Annual Cumulative Equality Impact Assessment of these from the previous civic year and publishes it on the Council's website. – link here

The key findings extracted from the assessment can be found below:

- Out of 85 decisions from Cabinet and Council, a total of 19 noted potential equality implications and the mitigating action either carried out or proposed, of these 19 decisions, 5 Equality Analysis Templates were completed.
- 45 decisions noted potential future equality implications however at the time of reporting, did not require action or completion of an Equality Analysis.
- 21 decisions highlighted no direct implications.

# **Cumulative Environment Impact Assessment**

In 2019, the Council passed a motion to declare a Climate Emergency. This declaration asserted the Council's commitment toward Climate Action beyond the current government targets and international agreements. Also, in July 2023, the Council declared an Ecological Emergency highlighting the need to address nature recovery, identify appropriate areas for habitat restoration and biodiversity net gain in the planning and development process while limiting impacts on existing habitats.

As part of the declaration, when Council policies are reviewed, specific consideration is given to how the policies and related decisions and actions affect our contribution to climate change, and where necessary, these policies are updated to reduce our impact where possible. The inclusion of an environmental implications section within reports and delegated decision templates ensures that impacts, mitigation measures and risks are identified at an early stage. Environmental Impact Assessments will include considerations that address air quality, biodiversity, adapting to climate change, landscape, noise and nuisance, waste management, water, and flood risks.

The key findings extracted from the assessment can be found below:

- Out of 85 decisions from Cabinet and Council, a total of 12 noted potential environment impacts and the mitigating action either carried out or proposed;
   0 Environmental Impact assessments were completed. It can be noted however that a number of Environmental Impact Assessments were completed for Delegated Decisions across the civic year 2023/24, these decisions can be found at <u>Delegated decisions 2024</u> and <u>Delegated decisions 2023</u>.
- 19 decisions noted potential future environment implications however at the time of reporting, did not require action or completion of an Environment Impact Assessment.
- 54 decisions highlighted no direct implications.

## 4. REASON FOR DECISION

4.1 The **District Wide Community Facilities Capital & Revenue Grants Panel** meetings held on 18 October 2024 considered applications for the North Herts Prosperity Fund and recorded their recommendation to the Executive Member for Community and Partnerships for the formal commitment of North Herts Prosperity Fund monies via the delegated authority process.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 There are no other reasonable alternative options.

# 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 Consultation has taken place with the District Wide Community Facilities Capital & Revenue Grants Panel members in a closed meeting on 18 October 2024. Members are in favour of the principle of the grant, subject to some conditions. There was consultation on a similar application and recommended that the North Herts Prosperity Fund should be used for this purpose.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

## 8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 This grant application was considered by the District Wide Community Facilities Capital & Revenue Grants Panel on 18 October 2024.
- 8.2 This delegated decision confirms that the recommendations made by the District Wide Community Facilities Capital & Revenue Grants Panel members were accepted by the Executive Member for Community and Partnerships, and Service Director on application outlined in 1.1.1
- 8.2.1 There were conditions placed on the release of funding regarding where the equipment would be stored and whether the storage had planning permission. The club has confirmed that they will now store the equipment in the Club House which belongs to their landlord Letchworth Garden City Heritage Foundation. They will in the meantime make enquiries regarding the shipping container on site and once the permissions are in place the equipment will be relocated.

#### 9. LEGAL IMPLICATIONS

- 9.1 The Executive Member has delegated authority to make these Executive decisions under section 14.6.9(b)((ii)A 5 of the constitution, in consultation with the Service Director: Legal & Community. That decision will be subject to a five clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 9.2 These grants have been assessed against the Subsidy Control Act 2022. Most of the proposals in this report are not subsidies as they do not relate to the supporting of goods or services that are also available commercially.

#### 10. FINANCIAL IMPLICATIONS

- 10.1. The available North Herts Prosperity Fund budget is £210,000.
- 10.2. Of the £210,000 allocated there is a prescribed Capital/Revenue split on the funding. The proportion of spend will be £130,000 capital funding and £80,000 revenue funding.
- 10.3 When all grants that have been recommended are taken into consideration, they represent a split of £140,657.00 capital spend and £69,343.00 revenue spend. While this does not quite meet the prescribed split set out in paragraph 10.2, this has been reviewed in the context of spend against the overall UKSPF grant and this variance does not create a problem. This has been confirmed by the Economic Development Officer and S151 Officer.
- There have been three meetings of the Community Facility Capital and Revenue Grant Panel on 3, 4 and 18th October 2024. Across all meetings, a total of £200,231 has been utilised. This leaves an available budget of £9,769

#### 11. RISK IMPLICATIONS

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 11.2 There is a requirement for allocated funds to be spent by the end of March 2025. Therefore, there is a risk that we will have to request the return of funds from applicants where projects have not been completed on time. This is assessed as

unlikely, as the application process included an assessment of each applicant's ability to commence their project as soon as funding is available and to progress work in a timely manner.

#### 12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 North Herts Prosperity Fund monies are awarded to groups that clearly demonstrate positive impact on the community and wider environment. The projects outlined in this report seek to advance equality of opportunity and foster good relations.

#### 13. SOCIAL VALUE IMPLICATIONS

13.1 The Social Value Act and "go local" policy do not apply to the matters contained within this report, as there are no recommendations on procurement.

## 14. ENVIRONMENTAL IMPLICATIONS

14.1 The Fund's criteria enabled application for projects related to environment and climate. In addition to this, in further developing the criteria and scoring process applicants were asked to confirm which of the Council's priorities their project supported. Therefore, applications which fulfilled the Council's Sustainability priority were able to score an additional point for this, which could aid in boosting their overall score.

- 1.1.3 £5,427 to ZEO CHURCH towards their Helping Hands project. *On condition that three relevant quotes are received.*
- 1.1.4 £19,775 to GREEN CARE AT NORTON towards a low-emissions van.

#### 4. REASON FOR DECISION

4.1 The **District Wide Community Facilities Capital & Revenue Grants Panel** meetings held on 18 October 2024 considered applications for the North Herts Prosperity Fund and recorded their recommendation to the Executive Member for Community and Partnerships for the formal commitment of North Herts Prosperity Fund monies via the delegated authority process.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 There are no other reasonable alternative options.

# 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 Consultation has taken place with the District Wide Community Facilities Capital & Revenue Grants Panel members in a closed meeting on 18 October 2024. Members are in favour and recommend that the North Herts Prosperity Fund should be used for this purpose.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

- The grant applications were considered by the District Wide Community Facilities Capital & Revenue Grants Panel on 18 October 2024.
- 8.2 This delegated decision confirms that the recommendations made by the District Wide Community Facilities Capital & Revenue Grants Panel members were accepted by the Executive Member for Community and Partnerships, and Service Director on applications 1.1.1-1.1.4.
- 8.2.1 With regards to the applications in 1.1.1-1.1.3 funds to be released on condition of receipt of relevant quotes.

#### 9. LEGAL IMPLICATIONS

- 9.1 The Executive Member has delegated authority to make these Executive decisions under section 14.6.9(b)((ii)A 5 of the constitution, in consultation with the Service Director: Legal & Community. That decision will be subject to a five clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 9.2 These grants have been assessed against the Subsidy Control Act 2022. Most of the proposals in this report are not subsidies as they do not relate to the supporting of goods or services that are also available commercially. The grant for Zeo Church partly relates to gardening and DIY services. Whilst these services would be available from commercial organisations, the overall focus on wider support means that it goes beyond commercial offerings. Therefore, it is not considered to be a subsidy.

#### 10. FINANCIAL IMPLICATIONS

- 10.1. The available North Herts Prosperity Fund budget is **£210,000**.
- 10.2. Of the £210,000 allocated there is a prescribed Capital/Revenue split on the funding. The proportion of spend will be £130,000 capital funding and £80,000 revenue funding.
- 10.3 When all grants that have been recommended are taken into consideration, they represent a split of £130,888.00 capital spend and £69,343.00 revenue spend. While this does not quite meet the prescribed split set out in paragraph 10.2, this has been reviewed in the context of spend against the overall UKSPF grant and this variance does not create a problem. This has been confirmed by the Economic Development Officer and S151 Officer.
- 10.4 Previously there have been two meetings of the Community Facility Capital and Revenue Grant Panel on 3 and 4 October 2024. Across both meetings, a total of £135,779 has been utilised. This leaves an available budget of £74,221.
- 10.5 The four grant applications in this delegated decision total **£64,452**.
- 10.6 The amount recommended at all grant panels totals £200,231. This leaves £9,769 remaining in the budget.

10.7 Any monies remaining after the completion of the North Herts Prosperity Fund process will be returned to the overall UKSPF underspent budget to be utilised by 31 March 2025.

#### 11. RISK IMPLICATIONS

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 11.2 There is a requirement for allocated funds to be spent by the end of March 2025. Therefore, there is a risk that we will have to request the return of funds from applicants where projects have not been completed on time. This is assessed as unlikely, as the application process included an assessment of each applicant's ability to commence their project as soon as funding is available and to progress work in a timely manner.

#### 12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 North Herts Prosperity Fund monies are awarded to groups that clearly demonstrate positive impact on the community and wider environment. The projects outlined in this report seek to advance equality of opportunity and foster good relations.

#### 13. SOCIAL VALUE IMPLICATIONS

13.1 The Social Value Act and "go local" policy do not apply to the matters contained within this report, as there are no recommendations on procurement.

#### 14. ENVIRONMENTAL IMPLICATIONS

14.1 The Fund's criteria enabled application for projects related to environment and climate. In addition to this, in further developing the criteria and scoring process applicants were asked to confirm which of the Council's priorities their project supported. Therefore, applications which fulfilled the Council's Sustainability priority were able to score an additional point for this, which could aid in boosting their overall score. Regarding the application for funding towards a van from Green Care at Norton CIC, the group have considered the purchase of an electric alternative to a diesel vehicle, but due to the availability of electric vehicles of a suitable nature this may not be possible. The applicant has advised they will strive to purchase an electric vehicle or a BlueHDi alternative. A larger van would mean less trips between sites.

#### 15. HUMAN RESOURCE IMPLICATIONS

15.1 The activities of the Community & Partnership team are covered by existing budgets.

Money for district groups helping kids with autism and ADHD, and to learn about the outdoors

All five of North Herts Council's community forums (Letchworth, Hitchin, Southern Rural, Baldock and Royston) have recently collectively awarded a total of £8,565 to Angels Support Group to support their online and face-to-face service helping families of autistic children and children with ADHD (attention deficit hyperactivity disorder).

Four community forums (Letchworth, Hitchin, Southern Rural and Baldock) also collectively awarded a total of £9,083 to Groundwork East for a growing and cooking scheme and wild play sessions focusing on outdoor learning in Knebworth.

Angels Support Group is an experience-led charity based in Hitchin which aims to make the world a better place for autistic children and young people and/or children and young people with ADHD, so they can meet their maximum potential in life. Funding will be used towards their online support groups and workshops for families across the district, which take place regularly during the day and in the evening, as well as their one-to-one service providing individualised support via phone calls, emails and meetings, some with professionals and at schools for instance.

Angels Support Group said: "These community grants will help us continue to support local families in North Hertfordshire at a time when there is a huge demand for our work but we are operating within a challenging fundraising climate. We are extremely grateful to the councillors for supporting us so we can reach and support the many families that need us. The families we support describe us as a 'life-line' and it means a lot to our families to know they are supported by their local communities."

Groundwork East's 'Grow It, Cook It, Share It' course will take place at a community facility in each area – Letchworth, Hitchin and Baldock – teaching families how to grow their own fruit and vegetables through supervised gardening, and how to prepare healthy meals

through simple cooking sessions. By working together on practical tasks and sharing food together, families will have the chance to develop their confidence, build friendships and support networks that will last beyond the formal learning environment.

The council's Southern Rural community forum agreed to help fund Groundwork's wild play sessions within the woodlands surrounding Knebworth House, focusing on the benefits of outdoor play - encouraging families to get outside to learn and improve both their physical and mental wellbeing.

Groundwork East said: "We are delighted to have been awarded these funds so we can offer some fantastic learning opportunities to local families. Evidence shows that being outside, playing and learning can hugely improve overall wellbeing. Our team is very excited to get started!"
