MEMBERS INFORMATION NOTE

East West Rail

A non-statutory consultation on the preferred alignment for the East West railway line between Bedford and Cambridge has started and will run until **24 January 2025**. The railway will have no direct impact on North Herts as it will run through Bedford, Central Bedfordshire and South Cambridgeshire. It will however open up routes via a new Tempsford station on the East Coast Mainline between St Neots and Sandy. The attached Information Sheet from England's Economic Heartland sets out the wider context.

A notable change since the last consultation includes a commitment to electrify most or all of the railway line. EWR's preference is not to electrify some sections, to save costs and reduce visual impact, and run hybrid battery-electric trains. It is unclear how well this arrangement would work for freight locomotives.

A better transport system across the region...

East West Rail will transform journey times between the towns and cities in the region, meaning it will often be faster to use the train than jump in your car.

But it's not just about getting to the places directly on the line. By connecting with the UK's most important rail lines, East West Rail will completely open up the UK for those living in the region. By connecting at an East West Rail station (rather than travelling into London), journeys to the likes of Birmingham,

Manchester, Newcastle, Bristol and Norwich will now be far easier by rail. Airports will also be within easier reach – including Luton, Stansted, Birmingham, Gatwick and East Midlands. And it will be a catalyst for wider transport improvements, including bus services and active travel.


In many ways, this is a case of the region going back to the future. The 'Varsity line', opened in 1846, had connected the region between Oxford and Cambridge, until its closure in 1968.

For the last 55 or so years, travelling by rail across the region has often required a change in London – making such journeys long, complicated and unrealistic. Yet, travelling by car is often also slow despite the relatively short distances involved.

This means that, at peak times, a journey between Oxford and Bletchley, which in 1853 took 75 minutes by train, can in 2024 take more than 140 minutes, and even 90 minutes by car. East West Rail will reduce this journey to 40 minutes.

The end-to-end journey time between Oxford and Cambridge will be just 90 minutes, served by up to four trains an hour.







High Wycombe and London including

consultation. England's Economic Heartland continues to make the strongest case for its delivery)










Cambourne to Cambridge

...connecting people to job opportunities...

East West Rail significantly expands the region's jobs market. Opportunities in places previously considered out of reach will very much now be in reach.

Faster, more productive and more affordable ways to travel will not only connect people to more jobs, but also to the widest possible choice of paths for their careers to take.

The region is home to some of the world's very best and most exciting industries and businesses at the cutting edge of technological and scientific development, including life sciences, advanced engineering, data and Al, and the creative sector. Now, those roles will be accessible to more people, especially those who cannot afford to live where the jobs may be located.


And again, it's not just those places on the line – centres of employment such as Northampton, Watford, Stevenage and Peterborough will also be within a single connection, as will the film studios such as Pinewood and Elstree in south Buckinghamshire and Hertfordshire.


There are 2.6 million jobs in the England's Economic Heartland region, including 25% of all England's life science roles, 12% advanced physics and engineering, and 10% digital and creative.

Those job numbers are only likely to further expand with businesses and investors supported and encouraged by East West Rail. There is a thriving startup scene and many of the companies that start here grow fast and become thriving businesses. Whether it's the likes of Oxford Nanopore or AbCam in Cambridge, Oxford and Cambridge produce the same number of 'Unicorns' as Berlin and Paris.

Milton Keynes, at the heart of the region, is a testbed for Al innovation, with over 1,000 people with direct Al or machine learning skills and is home to over 6,000 software engineers and 4,000 data engineers, while Cambridge's rate of patent applications – a key indicator of innovation – is the highest in the UK, at over 12 times the national average.

Moreover, with East West Rail, those businesses are more likely to locate throughout the region. With space in Oxford and Cambridge running out, the rail line will make it possible for businesses to grow by taking accessible and affordable space elsewhere along the railway line, much like Cambridge Medical Supplies has done by expanding into Ely. This will keep business growth in the region and spread the prosperity all the way along the East West Rail line.





...skills and education...

East West Rail is opening access to the widest choices of vocational training, apprenticeships and academic courses.

This is particularly important to young people, students and low-income households for whom access to skills and education is so important, and who are less likely to own a car and so rely on public transport.

East West Rail provides access to the University of Oxford, Oxford Brookes University, the Open University, University of Bedfordshire, Anglia Ruskin University and University of Cambridge, while the likes of Cranfield and Buckingham universities only require a short connection by bus. Other institutions, such as University of Northampton and University of Bedfordshire Luton campus are also within reach via a single connection.

Colleges and business schools will also be far more accessible, from the Said Business School in Oxford to the ludge Business School in Cambridge, and Milton Keynes College to Bedford College.

...leisure...

The places served by East West Rail offer some of Britain's best culture, museums, shopping and family days out, from the modern attractions of Bicester Village shopping centre or indoor skydiving and skiing in Milton Keynes, through to the historic cities of Oxford and Cambridge.

Travelling to these places by car, however, can be stressful, time consuming and expensive, - and, of course, may not always allow people to experience nightlife to the full.

By rail, journeys to these destinations are simple. As East West Rail connects more people to these attractions, simpler travel will boost the region's leisure, hospitality and nightlife industries — meaning even more places to go and more things to do.

Within a single interchange are attractions such as the Harry Potter Studio Tour in Watford (change at Bletchley – or alight there first to visit the famous home of the Codebreakers), while Blenheim Palace is a bus journey from Oxford Parkway Station. Communities in Winslow, Tempsford and and Cambourne will also be able to access fast trains into London for the first time.



...green spaces...

The East West Rail scheme will provide extensive opportunities for accessing existing green spaces as well as creating new spaces for local communities. This is a key consideration as part of the scheme's design, and East West Railway Company says it will work with local communities and partners to meet their needs and to establish ambitious targets for improving the region's quality of life through improving access to nature-rich green space in rural and urban areas, where appropriate, while maintaining a sense of wilderness and protecting species. A key enabling factor will be how the scheme links up the extensive network of rights of way across the region. The route will provide significant opportunities for meeting health and wellbeing ambitions, including the provision of access to areas for green social prescribing, and enabling greater access to leisure based enjoyment of nature, from pocket parks to biodiversity on our streets initiatives.

...and sustainable communities...

East West Rail has the potential to support sustainable communities, putting public transport at the heart of development and travel choices in the region. The proposed East West Rail route strongly aligns with allocated sites in local plans across the region, where house prices have become unaffordable for most of the population.

In Oxford and Cambridge, average house prices are 12 times more than average yearly earnings — compared to around eight times more nationally. This prevents many people from living in these areas and within a short commute of the available job opportunities. Many young people cannot see the region as their permanent and long term home, as they cannot afford to get on the housing ladder.

East West Rail will act as part of the solution to the region's housing problem by providing new connections from residential communities to the education and employment opportunities in the region's economic centres — and will unlock access to new affordable and sustainable homes, where increasing demand for the current supply is driving prices upwards.



...while regenerating existing places...

Increased connectivity will drive urban renewal and town centre regeneration throughout the region by attracting new investment and new housing in other town centres along the route.

East West Rail will create opportunities to reframe local stations as the gateway to their towns and stimulate regeneration. In Bletchley, this has already accelerated plans to develop the iconic Brunel shopping centre. A brand-new station in Bedford will improve access to the local hospital.

Oxford, Milton Keynes and Bedford all contain neighbourhoods which are among the top 10% most deprived in the country.

...reducing our impact on the environment...

Emissions from surface transport per capita in the England's Economic Heartland region are currently 30% higher than the UK average. Often people drive because they simply have no other choice – but East West Rail will change this directly, and will also acting as a catalyst for wider improvements to sustainable transport.

Rail travel can reduce emissions by up to 66% compared to travel by car. By giving people a choice in how they travel, and enabling them to cut their everyday emissions, the positive environmental effects of East West Rail will accelerate progress to net zero.

Locally, the positive effects will be more immediately felt. Getting people off the road and onto rail will reduce congestion and improve air quality, so walking through, and existing in, our urban areas will be more pleasant.

Following years of campaigning by local leaders, East West Railway Company announced this autumn that the trains would be powered through 'discontinuous electrification' rather than dirtier diesel.



...delivering biodiversity net gain...

By encouraging a modal shift from cars and lorries, East West Rail will reduce traffic congestion, improve air quality, promote environmental sustainability and support the UK's energy transition. East West Rail aims to be a net zero passenger railway and is exploring new technologies to power its trains that reduce carbon emissions and support the Government's ambitious climate agenda.

East West Railway Company says it is committed to finding ways to protect species development, so biodiversity is left in a better state than we found it. This includes through pledging a target of 10% biodiversity net gain for the route. The scheme's nine environmental principles are aligned to the regional principles, developed by the Oxford to Cambridge Pan Regional Partnership, and are being embraced by partners and the supply chain.

Creating sanctuaries for rare and protected species is a key commitment. East West Rail's first section between Oxford and Milton Keynes has already successfully established 20 Ecological Compensation Sites (ECS), designed to enhance connections between habitats and safeguard species across the route. These sites include 45 ponds, badger setts, over 70 bat boxes and more than 150,000 plants and trees have been planted. The sites have transformed previously low-diversity land into wildlife havens. Surveys conducted on the ECS to date demonstrate tangible successes and this is just the start.

...improving quality of life...

East West Rail will mean local people can spend less time stuck in traffic and more time focusing on what matters to them. Fast, stress-free, travel with lower carbon emissions mean happier residents and healthier communities. More efficient commuting routes open up affordable housing options in less well-served areas, supporting growth and investment. This will not only enhance the quality of life for residents and create access to jobs, it will also reduce costs for business, improve their productivity and drive growth.

...and unlocking local prosperity and UK economic growth.

With its knowledge-intensive sectors and world leading businesses, the Heartland region is uniquely placed to deliver economic advances quickly.

The connectivity East West Rail provides will enable Oxford, Bicester, Milton Keynes, Bedford and Cambridge to reach their full potential. The railway will ensure inclusive sustainable growth for everyone, including those areas that have fallen behind, while also unlocking economic growth for the whole of the UK. Better transport connectivity will make the region more attractive for international companies.

As they expand, so too will their investment in supply chains across the UK, just as AstraZeneca has shown with its further commitment to £650 million investment in the UK, which includes significant funding for not only this region but for England as a whole.

1 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor Tamsin Thomas.

2 MINUTES - 10 SEPTEMBER 2024

RESOLVED: That the Minutes of the Meeting of the Committee held on 10 September 2024 be approved as a true record of the proceedings and be signed by the Chair.

3 NOTIFICATION OF OTHER BUSINESS

There was no other business notified.

4 CHAIR'S ANNOUNCEMENTS

- (1) The Chair advised that, in accordance with Council Policy, the meeting would be recorded.
- (2) The Chair reminded Members that the Council had declared both a Climate Emergency and an Ecological Emergency. These are serious decisions, and mean that, as this was an emergency, all of us, Officers and Members had that in mind as we carried out our various roles and tasks for the benefit of our District.
- (3) The Chair drew attention to the item on the agenda front pages regarding Declarations of Interest and reminded Members that, in line with the Code of Conduct, any Declarations of Interest needed to be declared immediately prior to the item in question.
- (4) The Chair advised for the purposes of clarification that 4.8.23(a) of the Constitution did not apply to this meeting.

5 PUBLIC PARTICIPATION

There was no public participation at the meeting.

6 ITEMS REFERRED FROM OTHER COMMITTEES

The Chair advised that the item referred from the Overview and Scrutiny Committee would be taken with Item 7 on the agenda.

7 MUSEUM STORAGE OPTIONS APPRAISAL

RESOLVED: That Cabinet:

- (1) Noted the current projected costs, advantages and disadvantages of each option.
- (2) Approved use of £30k of the allocated £4m budget in the current capital programme for this project to develop more detail on the costs of Option D and to acquire the necessary details for a planning application to be made.

- (3) Approved use of £20k of the allocated £4m budget in the current capital programme for this project to develop more detail on the costs of Option E, should a suitable property become available.
- (4) Considered and gave approval for officers to apply for grant funding towards the investigations mentioned in 2.2 and 2.3 and recognise the need to align investigations with grant funding timetables in this instance.
- (5) Resolved to discount options A, B and G and recommend that they are no longer developed or explored further.
- (6) Indicated that Options C, F and H outlined within the report should be pursued further.

REASONS FOR DECISIONS:

- (1) Officers do not have the capacity or financial budget to progress all 8 options to an advanced stage and some early decisions are required in order to focus time and budget on pursuing the most advantageous options based on the best information available to officers and members at the present time.
- (2) In addition, the pursuit of greater detail on a number of the options will require expenditure on external reports and consultants which officers are seeking Cabinets approval to progress. Estimated figures are included in the main body of the report which can be found in Appendix 1 and are summarised in the Executive Summary Grid in Appendix 2.

4. REASON FOR DECISION

To allow settle the opportunity to comply with the terms of the exemption by applying the funds to the development of Social Housing.

5. ALTERNATIVE OPTIONS CONSIDERED

The decision is in accordance with the protocol entered into between North Hertfordshire District Council (NHDC) and North Hertfordshire Homes (NHH), now known as settle, in respect of a proposed disposal by settle of an asset transferred under the Stock Transfer. Therefore, no other alternative options are applicable.

6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

Settle have been consulted regarding the level of the potential clawback payment and the details of the social housing scheme to which the funds will be applied. There is no obligation on the Council to carry out any wider consultation.

7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 NHH changed its name to settle in May 2018.
- 8.2 Settle have submitted a request to agree an exemption to clawback in respect of Property at 2, Orchard Way, Breachwood Green, Hertfordshire SG4 8NT for the proceeds from the disposal to be used for the provision of Social Housing or

Community Benefit in the District of North Hertfordshire. Settle are relying on exemption xi in the deed of covenant dated 31 March 2003 which imposes the obligation to pay clawback.

- 8.3 The proposed project to which the proceeds will be applied is the John Barker Place regeneration project. Whilst it is still considered appropriate to suspend payment of the clawback for three years to allow settle the opportunity to invest the proceeds into Social Housing, The Council cannot at this stage agree the specific details of the Social Housing provision as until the precise proposals for the later phases of the John Barker Place regeneration project is known the clawback cannot be committed to those projects. Once the detail of the Social Housing to be provided by the John Barker place regeneration is known, together with the financial modelling, then the Council will determine whether this clawback should be allocated to that scheme or an alternative scheme.
- 8.4 Clawback is 25% of the greater of the Disposal Gain or the Development Gain. In this transaction, there is no Development Gain to consider, so the only relevant calculation is the Disposal Gain. The clawback calculation for the property has been agreed between the parties as follows:

9. LEGAL IMPLICATIONS

- 9.1 The Service Director: Resources has delegated authority for 'Approvals for any overage, claw back or similar arrangement pursuant to the Stock Transfer Agreement'.
- 9.2 The value paid by settle for the housing at stock transfer was based on its continued use as Social Housing. The deed of covenant provides compensation to the Council for property disposals by settle that are above the equivalent value at stock transfer. As the principle of this is to protect the volume of Social Housing in the District, there is an exemption that allows settle to reinvest this money into Social Housing or Community Benefit (as defined by the agreement) schemes within 3 years. The parties have entered into a protocol which governs how this exemption will operate in practice. The protocol permits the Council to suspend collection of clawback to allow settle the opportunity to comply with the terms of the exemption. As long as the request is reasonable then it should not be refused. So, this does not provide an opportunity for the Council to obtain additional funding.

10. FINANCIAL IMPLICATIONS

10.1 A significant amount of clawback has been suspended for use on the John Barker Place scheme. This clawback would take the total to £4,190,183.77. It has also been agreed that £1,760,000 of previously suspended clawback will be used on phases 1 and 2 of the John Barker Place scheme. Within its capital programme, the Council has also allocated £1.096 million towards this scheme. The overall value of the Social Housing within the scheme will need to be reviewed when a final proposal is in place. This will determine whether it is appropriate to confirm the use of the suspended clawback and also the use of the Council's own funding.

11. RISK IMPLICATIONS

11.1 No security is being sought to ensure payment of the clawback in the event that the social housing scheme is not delivered. Therefore, there is a risk that settle will not

have the funds to pay the clawback if they are unable to deliver the scheme. However this is considered unlikely.

4. REASON FOR DECISION

The Modern Slavery Act 2015 requires that commercial organisations with a turnover of at least £36 million to publish a slavery and human trafficking statement on an annual basis. The Council does not meet the definition contained within the Act but considers that it is good practice to publish a Modern Slavery Transparency Statement.

5. ALTERNATIVE OPTIONS CONSIDERED

The Council could choose to not publish a slavery and human trafficking statement. However, the Council supports the principles of the Act, so has chosen to publish a statement. The Council is bound by other provisions of the Modern Slavery Act.

6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

The Council's internal Contract and Procurement Group (which includes legal representation) have reviewed the proposed Statement.

7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 The Council has carried out the following actions in relation to Modern Slavery:
 - Delivery of training to Officers and Councillors.
 - Approved our first Modern Slavery Statement in June 2019 and updated each year since then.
 - Approved becoming a signatory to the Charter against Modern Slavery in July 2019.

- Implemented actions to enhance our processes in relation to Modern Slavery, including use of a Modern Slavery Identifiers checklist (for all appropriate procurements) and a risk assessment tool (for higher risk contracts).
- 8.2 The changes for the 2024/25 Statement (compared with the 2023/24 version) mainly relate to updates to website links.
- 8.3 Following approval, as well as publishing on our website, we will also add our Statement to the Government register website.

9. LEGAL IMPLICATIONS

- 9.1 The Modern Slavery Act 2015 (MSA 2015) applies to England and Wales and includes the offences of human trafficking and slavery, servitude and forced or compulsory labour. The Act consolidated and simplified existing offences and establishes a legal duty under Section 52 for specified public authorities to notify the Home Office where there are reasonable grounds to be believe a person may be a victim of modern slavery.
- 9.2 Section 54 of the MSA 2015 requires commercial organisations carrying out business in the UK, with a turnover of at least £36 million, to prepare and publish a slavery and human trafficking statement for each and every financial year. Whilst this does not apply to the Council, as detailed above we still choose to publish such a Statement.
- 9.3 The MSA created the role of the Independent Anti-Slavery Commissioner (the Commissioner) whose role is to act in the interests of victims and potential victims by ensuring that the law enforcement response to modern slavery is coordinated. 1 https://shivafoundation.org.uk/
- 9.4 Section 43 of the Act states that specified public authorities (including borough councils) have a duty to co-operate with the Commissioner. The Commissioner may request a specified public authority to co-operate with the Commissioner in any way that the Commissioner considers necessary for the purposes of the Commissioner's functions. A specified public authority must so far as reasonably practicable comply with a request made to it under this section.

10. FINANCIAL IMPLICATIONS

10.1. There are no financial implications relating to this decision.

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.

Modern Slavery Transparency Statement 2024-2025

1. Introduction

The Council has a key role to play in tackling modern slavery, including identifying and supporting victims and working in partnership locally. The Council's role can be separated into four distinct areas:

- 1. Identification and referral of victims.
- Supporting victims by safeguarding children and adults with care and support needs and providing housing/homelessness services.
- 3. Community safety and disruption activities; and
- 4. Ensuring the supply chains that the Council procures from are free from modern slavery.

Modern slavery intersects with many different areas that the Council is involved with, and a number of different officers might come across it while going about their everyday activities. Key examples, where officers might come across victims include housing and homelessness services, community protection work, licensing and customer services.

The procurement of services is an important part of the Council's expenditure. Understanding our supply chains and assessing the risk to those working in it, requires commitment, support, and collaboration. The Council is uniquely placed to be at the forefront of the fight against modern slavery. In line with best practice, and in compliance with Section 54 of the Modern Slavery Act 2015, this statement sets out the actions taken by the Council to understand, prevent and address modern slavery risks within its services and supply chains.

This statement sets out North Hertfordshire District Council's actions to understand the potential modern slavery risks related to its activities and to put steps in place to attempt to eliminate acts of modern slavery and human trafficking within its supply chain.

North Hertfordshire District Council are a signatory to the Charter Against Modern Slavery and support the principles of the Modern Slavery Charter.

2. NHDC's organizational structure & supply chains

North Hertfordshire District Council is a local authority in the north-eastern part of Hertfordshire, in the East of England region. The activities the Council undertakes are wide ranging in order to fulfil its duties to its residents. Its highest spend contracts are for the Household Waste Services and Grounds Maintenance. Its medium spend contracts are those spent on Carelines Services and IT Services. Its low spend contracts are for Repair

works.

The supply chains for the Council's activities are considered as only operating within the United Kingdom and the country's risk of slavery and human trafficking is therefore relatively low. However, the Council remains vigilant and will take all steps available to manage the risks presented. To assist, a check list of the modern slavery identifiers within supply chains has been produced for dissemination within the Council's service areas to increase awareness of identifying modern slavery risks within supply chains. The checklistis in line with the Government's PPN 02/23 recommendations. This checklist will be applied at the procurement stage of new contracts so that modern slavery risks can be managed at the outset of a contract. For existing supplier contracts, contract managers will be able to use the risk identifiers to highlight specific areas of risk for that good or service and then be able to seek further information from suppliers on the processes they have in place for mitigating that risk.

For high risk, high value procurement, suppliers will additionally be invited to complete the Government's Modern Slavery Risk Assessment tool. This tool is designed to help public sector organisations work with their suppliers in understanding where the risk of modern slavery exists within their supply chains.

3. Responsibility: who has responsibility for anti-slavery initiatives?

The Council believes that safeguarding is the responsibility of all employees, Members, volunteers, and organisations delivering services on our behalf. Everybody has a duty to safeguard children and adults in our local communities.

Our named Safeguarding Officer is our Service Director: Legal and Community. Designated Safeguarding Officers throughout the organisation support colleagues to respond and refer any concerns and a Corporate Safeguarding Group monitors current practice in relation to safeguarding and identifies key areas for development.

Responsibility for safeguarding sits with the Executive Member for Community and Partnership. An annual report is also made to the Overview and Scrutiny Committee.

Each Service area is responsible for reviewing spend on their supplier contracts as part of their ongoing commissioning and budget setting process. As part of this process, whenever spend is reviewed, it is considered best practice to include consideration of modern slavery.

Specified public authorities have a duty to notify the Secretary of State of any individual encountered in England and Wales who they believe is a suspected victim of slavery or human trafficking. The 'duty to notify' provision is set out in Section 52 of the Modern Slavery Act 2015 and applies to local authorities in England and Wales which includes North Hertfordshire District Council. 5. What due diligence of suppliers is carried out?

For the appointment of new suppliers above the relevant threshold for services, the Council uses the Government Standard Supplier Selection Questionnaire for all appropriate procurements and requests confirmation that suppliers meet Modern Slavery Act 2015 requirements. This was recently updated in line with Central Government recommendations as per PPN 03/24: Standard Selection Questionnaire (SQ) - GOV.UK (www.gov.uk)

The Council will utilize the Government Modern Slavery Statement Registry which is a central system where suppliers can publish their Modern Slavery Statements. This will allow the Council to easily assess information in relation to suppliers' compliance with the Modern Slavery Act 2015. Find modern slavery statements - GOV.UK (modern-slavery-statement-registry.service.gov.uk)

Any bidder who fails to evidence their compliance with the required legislation shall be excluded from participating further in the tender process. Incorporated within the Council's standard contract terms are clauses that specify the supplier's contractual obligation concerning Modern Slavery.

Any suppliers found not meeting the required standard will be asked to take action to improve; where this is not forthcoming the contract relationship will be terminated at the next opportunity, taking into account the contract terms and conditions.

6. Performance

The Council uses the following to measure how effective it has been to ensure that slavery and human trafficking is not taking place in any part of its business or supply chains:

Contract Managers will be invited to complete the Government Modern Slavery Risk Assessment tool for high-risk contracts.

☐ All employees will be provided with mandatory Safeguarding training.

7. How we train NHDC staff on anti-slavery measures

In 2018/19, training on modern day slavery was identified as mandatory for all staff and briefings and e-learning was rolled out throughout the organization (including to elected Members). Going forward, all staff are required to undertake safeguarding training at a level relevant to their role. Introductory, basic, and advanced training is refreshed every three years. This training now includes modern slavery and human trafficking. Compliance with these training requirements is monitored by the Leadership Team and audited by the Hertfordshire Safeguarding Children Partnership and Hertfordshire Safeguarding Adults Board.

The Procurement Officer as part of their role is required to maintain current knowledge of the latest developments in tackling modern slavery through dialogue with Hertfordshire Modern Slavery Partnership and through their professional CIPS membership (including through the Chartered Institute of Procurement and Supply, Ethical Procurement and Supply e- learning which will be retaken every 12 months.

This statement will be reviewed on an annual basis. This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes the North Hertfordshire District Councils modern slavery and human trafficking statement.

A lesson in democracy

The council's chamber was filled with students aged 16 to 18 last week, to help mark the annual UK Parliament Week (18-24 November).

On Thursday (14 November), around 35 young adults from local schools, visited the main council offices in Letchworth to meet local councillors, hear from local MPs and learn about the importance of local democracy. The day included input from Chris Hinchliff MP for North East Herts and Alistair Strathern MP for Hitchin, as well as the High Sheriff of Hertfordshire Annie Brewster JP.

A council overview and information on what happens at an election count was given, and students were split into smaller groups to enable them to get to know and ask questions directly to a cross-party group of district and county councillors. And to really help the young people get to grips with democracy, a council-style debate was held on whether the railways should be re-nationalised - and following a vote an informal motion was proposed that railways should be renationalised with funding ringfenced to support investment in services.

Cllr Val Bryant, Executive Member for Community & Partnerships, said: "It was great to host so many young people and see them get involved with all the activities we planned. The feedback has been very encouraging and I particularly enjoyed hearing what they had to say about re-nationalising the railways. It's so important for young people to learn about and become involved in local democracy – so they can appreciate how it affects their everyday lives and how it fits into the national picture."

Comments from attendees included:

- "I loved the debate, contributing was scary but worth it"
- "Very informational"
- "Learnt lots of new things, I liked the High Sheriff a lot"

- "Using voting buttons was a good experience"
- "Was very fun getting a chance to debate an issue and having an experience of what a council debate is like"
- "Good to ask about how and why councillors came to their posts, and their priorities"

Pupils came from five schools – Fearnhill in Letchworth, Knights Templar in Baldock, Hitchin Boys and Girls and Priory.

Local couple prove age is just a number in competitive athletics

While many their age are settling into retirement, Tim and Joy Saunders-Mullins are still actively competing in masters athletics.

At 70 and 71 years old respectively, the Letchworth couple continue to participate in national competitions, proving that athletic achievement knows no age limit.

Tim specialises in throwing events like hammer, discus and shot put while Joy competes in sprinting, javelin and shot put.

The pair train four times a week at the North Herts Leisure Centre, which is managed by Everyone Active in partnership with North Herts Council, where they've been members since the 1980s.

Their comprehensive training regime includes use of the gym, pool and sauna facilities. Tim focuses on power and strength training to support his throwing events, while Joy's programme combines speed, endurance, strength and power work for her track and field disciplines.

"I started running when I was 15 in school, and worked my way right up - juniors, seniors, and now masters. I was the 400m world champion record holder at the 2003 World Masters Athletics Championships in Puerto Rico," Joy said.

Joy and Tim compete through the British Masters Athletic Federation (BMAF), which organises age-group competitions starting from 35 years old in five-year increments.

"There's no age limit - we have people in our athletics that are over 85. There really is no limit to keeping active," Tim explains. He emphasises that the benefits extend beyond physical fitness, noting, "It calms me down, helps my anxiety. I feel more relaxed and can cope with things better."

Joy encourages others to start wherever they are. She says: "If you're completely new to fitness, there's plenty you can do from home. Even while sitting down, you can exercise your arms and legs. Then if you want to go further, you can visit the gym to meet like-minded people, or join a club if you're feeling adventurous."

The Saunders-Mullins couple are being featured as part of Everyone Active's "Age is Just a Number" campaign, which aims to challenge aging stereotypes and encourage seniors to embrace new activities.

Chris Williams, Everyone Active's area contract manager, said: "Tim and Joy are fantastic examples of how age shouldn't be a barrier to staying active and competitive. Having been members here since the 1980s, they're proof that maintaining an active lifestyle can be a lifelong journey. Their continued participation in masters athletics shows others that it's never too late to pursue their sporting passions."

Cllr Mick Debenham, North Herts Council's Executive Member for Leisure, said: "Tim and Joy's commitment to staying fit and competing in athletics well into their 70s is both impressive and inspiring. They're living proof that being active isn't just about keeping fit—it's about boosting your mood, staying connected, and embracing life to the fullest. We're proud to have facilities and programmes in North Herts that support residents of all ages to keep active."

Tim is currently recovering from a shoulder injury but Joy has her sights on the indoor and outdoor championships in 2025.
