Community & Partnerships Executive Member briefing – Nov 2024

Democratic Services

Committee Services

- Youth Democracy Day took place on Thursday 14 November and was another successful event, with good feedback received from Members and young people in attendance. We had two local MPs in attendance, a presentation from the High Sheriff, as well as a debate on 'Should the railways be re-nationalised?'
- Ensured Member attendance at the required Remembrance Day events across the district.
- Dedicated pages for Scrutiny have been launched on the Hub for Officers and Members to support their involvement in scrutiny. This was supplemented with an article in Insight and the Scrutiny Officer will be leading a session at the next SMG meeting in December.
- Will be interviewing three people for the vacant Committee, Member and Scrutiny Officer role, with interviews taking place on Thursday 21 November.
- Ongoing procurement review of our Committee Management System.
- Continuing with preparation for the Chair's Civic Event in February 2025, with formal invitations to be sent to relevant people and groups shortly. Tickets will be available via the Council website.

Electoral Services

- Annual canvass

- Route 1 properties have all been sent the CCA form which concludes their canvass cycle.

- Route 3 properties (these are properties such as care homes) are canvassed separately and we have had around half of the properties respond to us so far.

Submission of application to UK Government's Public Sector Decarbonisation Scheme Phase 4

29 November 2024

An application has been submitted to Phase 4 of the UK Government's Public Sector Decarbonisation Scheme (PSDS) for a grant towards decarbonising Hitchin Town Hall and North Herts Museum, District Council Office and the learner pool at North Herts Leisure Centre. Hitchin Town Hall and North Herts Museum have been treated as one building due to sharing heating systems.

This application follows our successful bid for a grant from Phase 3c of PSDS towards decarbonising our three leisure centres. Like our application last year, our submission was supported by Wilmott Dixon Construction Ltd who provided the technical and feasibility assessments to inform the application.

The buildings were chosen due to being gas heated sites with boilers that are reaching end-of-life, according to the definition from Salix (the organisation delivering the scheme on behalf of Government) and due to their contribution towards the Council's emissions.

Summary of the proposed project costs and carbon savings is set out below. Please note this is all subject to the application being successful.

Councillor Ralph Muncer to Councillor Nigel Mason, Chair of the Planning Control Committee:

- (1) What is the Council's policy regarding the application of its powers under the Listed Building Act 1990, the Town and Country Planning Act 1990, and the Buildings Act 1984, in respect of holding building owners to account for the dilapidation of Listed Buildings, especially for registered Assets of Community Value?
- (2) In particular, if the Council becomes aware that a Listed Building or building within a Conservation Area is at risk from dilapidation, to what extent will the Council allow the building to deteriorate before exercising its power to take formal legal enforcement action under the above acts?

(3) If the owner's maintenance of a Listed Building falls below the Council's minimum standard requirement (as in (2) above), and indeed the minimum standard required by legislation, how much time will the Council give the owner to restore the building to comply with informal requests and comply with statutory requirements before taking formal legal action to protect the historic building?

RESOLVED: That application 23/02895/OP be **GRANTED** planning permission subject to the reasons and conditions set out in the report of the Development and Conservation Manager with the removal of Condition 13, the amendments to Conditions 11,12 and 14 as set out in the supplementary document and the relevant renumbering of existing conditions.

"Condition 11:

Landscape and Ecological Management Plan (LEMP)

'Prior to commencement of the development, a Landscape and Ecological Management Plan shall be prepared, detailing how biodiversity will be incorporate within the development scheme and managed/monitored long-term. This should include details regarding who will have the management responsibilities. The plan shall include details of the landscaping proposed to achieve measurable gains to biodiversity, as well as a graphical plan which sets out the number, type and position of ecological enhancement features to be incorporated into the design scheme. This plan shall be submitted to the Local Planning Authority for written approval to demonstrate the expectations of the NPPF and Local Policy in achieving overall measurable net gains for biodiversity. The development shall be carried out in accordance with the approved plan unless otherwise agreed in writing with the Local Planning Authority.

Reason: To ensure sensible working practices which protect ecology on and adjacent to this site, in accordance with Policy NE4: Biodiversity and Geological Sites.

Condition 12

Construction Environment Management Plan (CEMP)

No development shall take place until a Construction Environmental Management Plan (CEMP) for biodiversity has been submitted to and approved in writing by the local planning authority. The CEMP shall include the following:

- a) Risk assessment of potentially damaging construction activities.
- b) Practical measures (both physical measures and sensitive working practices) to avoid or reduce impacts during construction (may be provided as a set of method statements). This must include:
 - *i.* Best practice measures to ensure the protection of retained vegetation during construction;
 - *ii.* Best practice measures to ensure any invasive species listed on Schedule 9 of the Wildlife and Countryside Act 1981 encountered within the site will be removed and disposed of as controlled waste;
 - *iii.* A precautionary working method for hedgehogs.

- c) The location and timings of sensitive works to avoid harm to nesting birds.
- d) Details of a translocation programme for slow-worms.

The CEMP should include a statement to the effect that if any protected species are encountered during any stage of the development, then works must cease immediately and advice be sought from a suitably qualified ecologist on how best to proceed. Development shall proceed in accordance with the approved CEMP, unless otherwise agreed in writing by the Local Planning Authority.

Reason: To ensure sensible working practices which protect ecology on and adjacent to this site, in accordance with Policy NE4: Biodiversity and Geological Sites.

Condition 13:

Lighting Strategy

No development shall take place until an external lighting scheme has been submitted to and approved in writing by the Local Planning Authority. This scheme should follow guidance from the Bat Conservation Trust and Institution of Lighting Professionals (2023), and be designed to minimise light spill, in particular directing light away from boundary vegetation to ensure that dark corridors remain for use by wildlife as well as directing lighting away from potential roost / nesting sites. This should be accompanied by a short statement from a suitably qualified ecologist showing how the design meets the level of protection required.

Reason: To ensure protected species are not disturbed by the development in accordance with National Legislation (Conservation of Habitats and Species (Amendment) (EU Exit) Regulations 2019, Wildlife and Countryside Act 1981 (as amended)) and Local Planning Policy NE4 – Biodiversity and geological sites."

North Herts tourism thrives with record recovery in both overnight stays and economic impact

According to data published today, North Herts has emerged as a top choice for overnight stays, with the latest tourism statistics showing a significant rebound post-pandemic, underscoring the district's appeal as a must-visit destination. Local Visitor Economy Partnership (LVEP) Visit Herts commissioned the study which uses the industry-respected Cambridge Economic Impact Model to measure the volume and value of tourism within a destination, as well as the effect of visits and visitor expenditure on the local economy.

The detailed report confirms that North Herts' tourism industry is nearing pre-pandemic levels, **with 190,900 overnight stays recorded in 2023**. This demonstrates 37% growth versus stays in 2021.

The latest findings also reveal that **overnight visitors to North Herts contributed £51 million to Hertfordshire's economy in 2023**, marking an impressive 13% increase versus 2019. Notably, spending per overnight trip has also risen by 14% since 2019, emphasising a growing trend toward extended stays and weekend breaks.

Visit Herts also reports strong gains in total visitor numbers, with **2.9 million people choosing to visit North Herts in 2023**, representing a 19% increase compared to 2021.

The **value of tourism in North Herts reached £221 million in 2023**, which is now on par with pre-pandemic levels. With such impressive recovery figures, the district's tourism sector is once again proving its vital role within the local economy.

Tourism also continues to boost local employment, supporting 4,126 jobs across North Herts, representing 6% of total employment within the district. This growth reflects the pivotal role of tourism in North Herts' economic health and its strong recovery trajectory.

Cllr Tamsin Thomas, Executive Member for Enterprise at North Herts Council, said: "It's great to see how North Herts is becoming a real draw for visitors. These figures show just how much people enjoy exploring our district, whether it's for the stunning countryside, historic towns, or welcoming atmosphere. Tourism plays a key role in boosting our local economy and supporting jobs, and we're committed to helping it thrive even more in the future." **Visit Herts Chief Executive, Deirdre Wells, OBE, said:** "Hertfordshire's resurgence as a top destination for overnight stays is a testament to its unique charm, rich history, and beautiful countryside that resonates with visitors seeking both relaxation and discovery. These strong recovery figures affirm the vital role tourism plays in our local economy, not only in driving visitor spending but in sustaining thousands of jobs.

As we continue to celebrate Hertfordshire's growing appeal, it's crucial to acknowledge the industry's ongoing challenges, particularly with the current economic pressures and operational costs that our local businesses face daily. While we're encouraged by the progress in overnight stays, the sector is still navigating recovery in international visits with factors like inflation and the cost-of-living impacting traveller spending.

Through our newly launched <u>Destination Management Plan</u>, we're committed to addressing these challenges head-on, supporting our partners, and advocating for policies that help sustain the industry. It's clear that, despite the strides we've made, there is more work ahead to ensure full recovery and continued growth for tourism in Hertfordshire."
