NOTICE IS HEREBY GIVEN that the North Hertfordshire District Council (pursuant to arrangement made with Hertfordshire County Council) has made the above Orders under the Road Traffic Regulation Act 1984. The general effect of the Orders will be to introduce a Restriction of Waiting in Souberie Avenue, Letchworth, No Waiting at anytime except Taxis in Bancroft, Hitchin and amendment to the current parking for permit holders in Church Street, Baldock as described in the Schedules to this Notice.

The above named Orders will come into force on 19th December 2024

Copies of the Orders, the plans and the statement of reasons may be inspected during normal office hours (by appointment only) at the offices of North Hertfordshire District Council, Gernon Road, Letchworth and on the Council's website at www.north-herts.gov.uk . Any person wishing to question the validity of the Orders, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date on which the Orders were made apply to the High Court for this purpose.

Bancroft (on the Eastern side)

from a point 4 metres south of boundary between no's 106 and 107a Bancroft, for a distance approximately 83 metres in a northerly direction to a point approximately 8 metres north of the boundary between Nos' 98 and 99 Bancroft.
