MEMBERS INFORMATION NOTE

East West Rail

A non-statutory consultation on the preferred alignment for the East West railway line between Bedford and Cambridge has started and will run until **24 January 2025**. The railway will have no direct impact on North Herts as it will run through Bedford, Central Bedfordshire and South Cambridgeshire. It will however open up routes via a new Tempsford station on the East Coast Mainline between St Neots and Sandy. The attached Information Sheet from England's Economic Heartland sets out the wider context.

A notable change since the last consultation includes a commitment to electrify most or all of the railway line. EWR's preference is not to electrify some sections, to save costs and reduce visual impact, and run hybrid battery-electric trains. It is unclear how well this arrangement would work for freight locomotives.

SERVICE DIRECTORATE: Legal and Community

1. DECISION TAKEN

- 1.1 The approval of the allocation of **North Herts Prosperity Fund (NHPF)** funding of:
- 1.1.1 £18,246.00 to HOWARD GARDEN SOCIAL CENTRE towards replacement the heating system to make the building more energy efficient
- 1.1.2 £16,041.33 to WALSWORTH COMMUNITY CENTRE towards air conditioning and flood defences on exterior doors.

2. DECISION TAKER

2.1 Cllr Val Bryant, Executive Member for Community and Partnerships, in consultation with the Service Director – Legal and Community.

3. DATE DECISION TAKEN:

9 January 2025

4. REASON FOR DECISION

4.1 The applicant in 1.1.1 and 1.1.2 have confirmed a need for this funding and confirmed they will be able to use the funding by the hard deadline of 31 March 2025.

5. ALTERNATIVE OPTIONS CONSIDERED

5.1 There are no other reasonable alternative options.

6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 Consultation has taken place with the Community Partnerships team.

7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 The North Herts Prosperity Fund initially had £210,000 to allocate to Parishes and Voluntary, Community and Social Enterprise (VCSE) organisations.
- 8.2 A further £66.780 has been identified to be utilised for the Fund.

- 8.3 This delegated decision confirms that application 1.1.1 and 1.1.2 has been accepted by the Executive Member for Community and Partnerships, and Service Director.
- 8.4 The grant funding to Howard Garden Social Centre will be made under the condition that payment will be released on receipt of a suitable and robust safeguarding policy. The organisation are working to update their current policy and it is expected that this will be received by the time this decision is ratified.

9. LEGAL IMPLICATIONS

- 9.1 The Executive Member has delegated authority to make these Executive decisions under section 14.6.9(b)((ii)A 5 of the constitution, in consultation with the Service Director: Legal & Community. That decision will be subject to a five clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 9.2 This grant has been assessed against the Subsidy Control Act 2022.

10. FINANCIAL IMPLICATIONS

- 10.1. The available North Herts Prosperity Fund budget is £66,780.
- 10.2. Of the allocated there is a prescribed Capital/Revenue split on the funding. The proportion of spend will be £43,715 capital funding and £23,065 revenue funding.
- 10.3. £17,169 has been utilised on a grant funding provided to the Letchworth Garden City Community Group in a decision made on Friday 3rd January 2025 leaving **£49,611** for the two grants outlined in this report.
- 10.4 If the grant applications contained in the delegated decision equates to £34,289.33 is awarded as outlined in 1.1.1 and 1.1.2 the remaining balance will be £15,321.67
- 10.5 It is possible that when all applications have been taken into account that the prescribed capital / revenue split may not be met as set out in paragraph 10.2. However, this has been reviewed in the context of spend against the overall UKSPF grant and this variance does not create a problem. This has been confirmed by the Economic Development Officer and S151 Officer.
- 10.6 Any monies remaining after the completion of the North Herts Prosperity Fund process will be returned to the overall UKSPF underspent budget to be utilised by 31 March 2025.

11. RISK IMPLICATIONS

- 11.1 Good Risk Management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 11.2 There is a requirement for allocated funds to be spent by the end of March 2025. Therefore, there is a risk that we will have to request the return of funds from applicants where projects have not been completed on time. This is assessed as unlikely, as the application process included an assessment of each applicant's ability to commence their project as soon as funding is available and to progress work in a timely manner.

11.3 As the applications contained in this report are all for works to buildings that are owned by North Herts Council on full repairing leases to the relevant community groups / charities who operate the buildings, any risk involved in the organisation becoming insolvent is mitigated by the fact that the investment will be made to support community facilities that can be repurposed and would be fit for use by another group.

12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 North Herts Prosperity Fund monies are awarded to groups that clearly demonstrate positive impact on the community and wider environment. The projects outlined in this report seek to advance equality of opportunity and foster good relations.

13. SOCIAL VALUE IMPLICATIONS

13.1 The Social Value Act and "go local" policy do not apply to the matters contained within this report, as there are no recommendations on procurement.

14. ENVIRONMENTAL IMPLICATIONS

- 14.1 The Fund's criteria enabled application for projects related to environment and climate. In addition to this, in further developing the criteria and scoring process applicants were asked to confirm which of the Council's priorities their project supported.
- 14.2 The grant funding agreed for the Howard Garden Social Centre to replace the current heating system needs to be undertaken as a matter of urgency as the current heating is not fit for purpose and in danger of being condemned. The facility is predominantly used for social interaction for elderly people many of who suffer from social isolation which makes it imperative that they have a warm space for service users.

Although the heating system will be like for like gas boiler, the cost of installing a heating system such as ground source heat pump or electric heating would be cost prohibitive. The new hating system would enable environmental improvements compared to the existing system, in that it would increase energy efficiency and be cheaper to run.

15. HUMAN RESOURCE IMPLICATIONS

15.1 The activities of the Community & Partnership team are covered by existing budgets.

2 MINUTES - 13 NOVEMBER 2024

RESOLVED: That the Minutes of the Meeting of the Committee held on 13 November 2024 be approved as a true record of the proceedings and be signed by the Chair.

3 NOTIFICATION OF OTHER BUSINESS

4 CHAIR'S ANNOUNCEMENTS

- (1) The Chair advised that, in accordance with Council Policy, the meeting would be recorded.
- (2) The Chair drew attention to the item on the agenda front pages regarding Declarations of Interest and reminded Members that, in line with the Code of Conduct, any Declarations of Interest needed to be declared immediately prior to the item in question.

6 INTERNAL AUDIT REPORT – REVIEW OF FINANCE, AUDIT AND RISK COMMITTEE

RESOLVED: That the Committee commented on and noted the Internal Audit report as attached at Appendix A.

REASON FOR DECSION: To allow the Committee to discuss the findings of the Internal Audit report, and contribute to the actions to improve the effectiveness of the Committee.

7 REVENUE AND CAPITAL BUDGETS FOR 2025/26 ONWARDS

RECOMMENDED TO CABINET: The Finance, Audit and Risk Committee commented on the recommendations to Cabinet, which are:

- (1) That Cabinet notes the Council's expected funding for 2025/26.
- (2) That Cabinet confirms (in line with the Medium-Term Financial Strategy) that budget forecasts should be based on increasing Council Tax by 2.99% (the maximum amount allowable without a local referendum). Noting that Government have assumed Council Tax will increase by the maximum allowed in calculating Core Spending Power.

- (3) That Cabinet notes that the Council may see real-term reductions in its funding in future years.
- (4) That, in the context of the above, Cabinet agree which proposals (revenue and capital) should be taken forward as part of the budget-setting process for 2025/26.

REASON FOR REFERRAL: To ensure that all relevant factors are considered in arriving at a proposed budget, Investment Strategy and Council Tax level for 2025/26, to be considered by Full Council on 27 February 2025.

8 REPORT ON RISK MANAGEMENT GOVERNANCE (MID-YEAR UPDATE)

RESOLVED: That Finance, Audit and Risk Committee noted and provided recommendations to Cabinet on this mid-year Risk Management governance update.

RECOMMENDED TO CABINET: That Finance, Audit and Risk Committee commented on the changes to the Risk Management Framework and recommended to Cabinet that they approve the changes.

REASONS FOR REFERRAL:

- (1) The responsibility for ensuring the management of risks is that of Cabinet.
- (2) This Committee has responsibility to monitor the effective development and operation of Risk Management.

9 SECOND QUARTER REVENUE BUDGET MONITORING 2024/25

RECOMMENDED TO CABINET: The Finance, Audit and Risk Committee commented on the recommendations to Cabinet, which are:

- (1) That Cabinet note this report.
- (2) That Cabinet approves the changes to the 2024/25 General Fund budget, as identified in table 3 and paragraph 8.2, a £550k decrease in net expenditure.
- (3) That Cabinet notes the changes to the 2025/26 General Fund budget, as identified in table 3 and paragraph 8.2, a total £306k increase in net expenditure. These will be incorporated in the draft revenue budget for 2025/26.
- (4) That Cabinet approve the debt write-offs detailed in paragraphs 8.16 and 8.17.

REASON FOR REFERRAL: Members are able to monitor, make adjustments within the overall budgetary framework and request appropriate action of Services who do not meet the budget targets set as part of the Corporate Business Planning process.

10 SECOND QUARTER INVESTMENT STRATEGY (CAPITAL AND TREASURY) REVIEW 2024/25

RECOMMENDED TO CABINET: The Finance, Audit and Risk Committee provided comments on the recommendations to Cabinet, which are:

(1) That Cabinet notes the forecast expenditure of £15.699M in 2024/25 on the capital programme, paragraph 8.3 refers.

Wednesday, 8th January, 2025

- (2) That Cabinet notes the position of the availability of capital resources, as detailed in table 4 paragraph 8.6 and the requirement to keep the capital programme under review for affordability.
- (3) That Cabinet recommends to Council that it notes the position of Treasury Management activity as at the end of September 2024.
- (4) That Cabinet recommends to Council that it approves capital budgets in 2025/26 for a new flume (£300k) and a refurbishment of the pool changing rooms (£250k) at North Herts Leisure Centre, subject to the revised assessments following the decision by Cabinet regarding Public Sector Decarbonisation Scheme on 14 January 2025.

REASONS FOR REFERRAL:

- (1) Cabinet is required to approve adjustments to the capital programme and ensure the capital programme is fully funded.
- (2) To ensure the Council's continued compliance with CIPFA's code of practice on Treasury Management and the Local Government Act 2003 and that the Council manages its exposure to interest and capital risk.
- (3) The proposal to approve the 2025/26 capital budgets at North Herts Leisure Centre in January (rather than in the usual budget report at the end of February) means that the works can take place at the same time as the decarbonisation works, and therefore not require two periods where the pool cannot be used. It also provides a more obvious benefit to users of the facility.
