# THE NORTH HERTFORDSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (BALDOCK) No. 3 ORDER 2024

NOTICE IS GIVEN that the North Hertfordshire District Council ("the Council") has made the above Orders under the Road Traffic Regulation Act 1984. The general effect of the Orders will be to revoke: The North Hertfordshire District Council (Off –Street Parking Places) Order 2014, The North Hertfordshire District Council (Off-Street Parking Places)(Knebworth) Order 2011, The North Hertfordshire District Council (Off-Street Parking Places) (Knebworth) (Amendment) Order 2012 and the North Hertfordshire District Council (Off-Street Parking Places) (Baldock) No. 2 Order 2014 and replace these with new Orders which introduces alternative methods of payment, virtual permits and season tickets, and reviews the definitions and length of stay for electric vehicle parking bays within the Council's car parks. All off street parking places are affected by the Orders as specified in Schedule 1 of this Notice.

The above-named Orders will come into force on 18th February 2025.

Any person wishing to question the validity of the Orders, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date on which the Orders were made apply to the High Court for this purpose.
